## Instructions:

Sort By Rank: sort by lowest Net Price.

CDN or US Carrier: Set according to your home jurisdiction. The exchange rate will displayed accordingly. If you are a QST registrant, enter Y in cell P6 so it calculates the price net of QST and GST.
