### Instructions:

Update any of the cells in RED. After doing so, click one of the SORT BY buttons to recalculate the ranking. Also, update the "as at date" so you remember when you last changed the fuel prices.

**Exchange Rate:** Enter the current exchange rate (check with your bank, credit card company or fuel supplier).

**Fuel Price (at the pump):** For each St/Prov, enter the total pump price including all taxes.

**Sort By St/Prov:** alphabetically sort by province and state

**Sort By Rank:** sort by lowest Net Price.

**CDN or US Carrier:** Set according to your home jurisdiction. The exchange rate will displayed accordingly. If you are a QST registrant, enter Y in cell P6 so it calculates the price net of QST and GST.

It is presumed that GST/HST refunds are being received on all fuel purchased in Canada.
